8' x 4'. One skirted (flame resistant) 8' x 2' table and two chairs will be provided.  
No table space extension allowed.

Confirmation of registration acceptance will be dependent upon available space, type, uniqueness of products and compliance with application criteria. In keeping with the spirit and character of this traditional Christmas market, vendors of high-quality, hand-made Christmas related gift ideas of Canadian or Central European origin will be given preference.

**Fire Regulations (excerpt):**

1. Ensure the width of the exit corridors is not compromised by vendor tables.  
Maintain 8 foot aisle width.
2. Table cloth and other decorative material shall be treated with a fire retardant that conforms to CAN/ULC S109 Tests for Flame Resistant Fabrics and Films. Excessive use of plastic or paper is not permitted.
3. In case of emergency the fire alarm will ring. All customers and vendors shall vacate the area unless an announcement from building staff indicates otherwise. In case of evacuation Christkindlmarkt staff will monitor and supervise the vendors' displays in the hall area.
